#### CADLEROCK PROPERTIES

On November 19, 2021 the Town Clerks of both Ashford and Willington were presented with Quit Claim Deeds transferring a total of 12 land parcels (10 in Ashford and 2 in Willington totaling 351.68 acres) to their respective town. These transfers of ownership, initiated by an adjourned tax sale first held in October of 2011, came as the result of the reopening of that tax sale in May of 2021. At that time, the various owners of these parcels had 6 months to make current on their tax arrears and applicable penalties or forfeit the properties to the towns.

Failure on the part of Cadlerock Properties Joint Venture, L.P. and Cadlerock Properties of Connecticut, Inc. to redeem the 12 parcels resulted in the towns of Ashford and Willington assuming ownership. Thus, on November 19, 2021 the Towns of Ashford and Willington became the owners of the subject properties.

As a result of investigations undertaken by Connecticut's Department of Environmental Protection in 1991 a consent order (ordering targeted sites to be cleaned up) was placed on all 12 parcels. Based upon DEP's findings on lot 11 (located in Willington), the U.S. Environmental Protection Agency was called in to further investigate and perform a remedial action.

The bundling of the 12 parcels by the DEP was looked upon favorably and made it possible for Willington and Ashford to regionalize their brownfield assessment application. In 2017, the towns of Ashford and Willington filed a joint application with the Connecticut Department of Economic and Community Development, Remedial Action and Redevelopment Municipal Grant Program to assess the extent of contamination remaining on the Cadle parcels. In order to access the site, the towns relied on Section 22a-133dd of the Connecticut General Statutes which allowed us "to perform environmental site assessment or investigations on behalf of the municipalities." Shortly after award of the \$200,000 assessment grant, the towns contracted with BL Companies to perform an in-depth site assessment, in two phases, which was completed in December of 2020.

Another consequence of the bundling was the placement of two, non-specific liens placed against the entire 12 parcels by the DEP and the EPA. Some form of negotiating release of these liens (\$282,000 to the DEP and \$4,394,562.87 to the EPA) will have to be taken into account when use options are considered.

In preparation for applying for a remediation grant in the fall of 2020, the towns authorized BL Companies to prepare a remedial action plan, targeting areas around the property that remain to be investigated and/or cleaned up. Unfortunately, our remediation application was not awarded. We surmise that one of the reasons we were denied related to the fact that the towns did not own the property so would have no legal entry onto the property.

Connecticut's Office of Policy and Management has announced the opening of a remediation grant round in July or August of this year. With ownership now resting with the towns, the Boards of Selectmen (of both Ashford and Willington) have voted to authorize submission of a remediation grant application in the amount of \$300,000 (which is reimbursable – both the expenditure and the reimbursement have been included in the Capital Projects section of Ashford's 2022-2023 budget).

If awarded and we are allowed to continue working on bringing this acreage into productive use, be it some kind of development or recreational, we plan to hold a series of public hearings to share ideas with you on future plans for the property.

#### **Ashford Pollinator Pathway News**

Greetings Ashford! Dead lawn thanks to drought and summer heatwaves? Rethink it! Instead of replanting with standard non-native lawn mixes, consider using native grasses or developing a native plant garden in its place. Lawns need a lot of water to maintain (nationally up to 9 billion gallons of water per day according to the EPA!) -- their root systems are too shallow to handle drought or filter stormwater runoff. Homeowners use 10xs the amount of pesticides and fertilizers per acre on their lawns compared to crop farmers, and much of it goes into wetlands, rivers, and negatively impacts habitats and human



health. Lawns provide no habitat for pollinators and animals that rely on insects to survive. Finally, lawns are expensive – according to the National Gardening Association, Americans spend around \$50 billion caring for their lawns every year.

Native plants and grasses, on the other hand, often have deep roots that can better handle heat and drought. They require less water and no pesticides or fertilizer, keep soil and nutrients in place, and are cheaper to maintain once established. Native plants also provide food and habitats for native insects, birds, and other creatures. Converting some or all of your lawn to a native plant garden, meadow or woods saves you time, money & helps the environment. Many on-line nurseries sell plug kits to get native plant meadows and gardens started. ### **Spotlight: Melinda MacDonald, Ashford PP Steering Committee**

**Member**, has been gardening for years, but her focus has evolved over time. She was raised in the suburbs of Ohio, surrounded by manicured lawns and thirsty annuals. In the late 80s she won a drawing at a local nursery



for a starter perennial garden and became obsessed with garden design. She poured over garden catalogs, attended garden tours, and joined a garden club. Then came vegetables – she and her husband joined a CSA where they had to work for their share. Suddenly, flower beds seemed superficial and she began growing food while her flower beds became wild and overgrown. The pollinators were quite pleased with this shift - everything was abuzz! Today she remains a hobby gardener, but her focus has broadened to include beautiful flowers, vegetable bounty, and a sharpened focus on what makes all of this possible - the pollinators! She is also a volunteer member of the Sustainable CT committee, working on Ashford's application for recertification with a focus on actions relating to the Pollinator Pathway, community growing spaces, and homelessness prevention.

#### **Native Grass Alternatives**

<u>Buffalograss</u>: Native across the central part of the country, it's a tough, durable alternative and very drought tolerant

<u>Sedges</u>: Some varieties of this native grass-like plant grow in well-drained, sandy or clay soils. One of the most popular varieties is Pennsylvania sedge.

<u>Mosses</u>: Ideal for homeowners with lots of shade; good for erosion control, creates a natural water-filtration system, and does not die back in the winter.

White Clover Lawn: Drought and disease resistant, grows in poor soil, and unfazed by dog urine!
Other Native Grasses: Blue Grama (western North America) and Red Fescue (west of the Rockies, New England south to the Appalachian Mountains).

#### **Non-Grass Ground Covers:**

Bearberry, Lowbush Blueberry, Barren Strawberry (in shade), Partridge Berry and Creeping Juniper. None look like lawn, but they are low growing, attractive, beneficial to wildlife & drought resistant.

I want to thank the entire sustainable team that worked extremely hard to get our application in top shape. Our team members are Christine Acebo, Janet Bellamy, Stephanie Dubinsky, Susan Eastwood, Kathryn Edison, Kit Eves, Marian Matthews, Melinda MacDonald, and Melissa McDonough. Plus, big thanks to all the workers at Town Hall who gave us assistance as we muddled through this very difficult process. Gratitude goes to our sustainable fellow (intern) Haylee Scibek.

As part of our work, we looked at the amount of waste generated in our town and how many tons of waste was carried from our transfer station to Willimantic Waste. Here is what we discovered and posted on our town website:

Hopefully the town will reap the benefits of all our work and all residents will work to help our town stay vibrant, green and sustainable. (Continued on next page.)



#### **Solar Statement**

After years of dreaming and scheming where to build our green home, a number of things led us to settle in Ashford. As we honed in, we were fortunate to find the perfect hill with a tapered slope facing due solar south. We were also fortunate to discover that our building schedule coincided with a three-town Solarize program – perfect timing! The smart incentives of this program in tandem with regular state and federal rebates allowed us to solarize our new home for just over 50% of the normal cost.

So many energy-saving puzzle pieces are easy to fit together when building new. Orienting our saltbox style frame on the tapered slope, we were able to place a tall wall and a long roof in the solar south direction. The traditional tall "front" has passive solar windows on three levels thanks to a walkout basement and a second-floor dormer. The long saltbox roof, non-traditionally, also faces south thanks to a basement walkout on the downslope, and it provides a perfect platform for solar panels. The continuing slope of the hill allowed us to leave some tall trees for summer ground shade, without shading the roof panels. With the ample solar panel platform, it made the most sense (for the fewest dollars) to choose electric mini-split heat pumps for our air heating and cooling system and even to go with electric heat pump technology for our hot water. The improved cold-climate engineering and performance of the heat pumps proved too hard to resist, and this technology keeps improving.



Something that still needs improving is Connecticut's solar incentive policy. Our utilities and regulators provide incentives only for the limited amount of electricity needed for a household, placing an illogical cap on sites that could produce lots more juice. Under the smarter policies of other northeastern states we could have put our entire long saltbox roof to use, harvesting clean electricity and feeding surplus to the grid. Nevertheless, building new did allow a flexible formula (in place of past household electric bills) to tally up the solar array size that was eligible for incentives. With frugal use of our two-ton heat pump system, careful choice of efficient appliances, and the simple use of natural daylighting and shading, we consume less electricity each year than our 9.8kW solar array generates. We're filling our own need, and also feeding some clean energy back to the grid.

#### **Assessment News**

### Exemption program for motor vehicles currently registered in the Town of Ashford that are adapted for persons with a disability

The Town of Ashford has an ordinance exempting certain vehicles specially adapted for persons with disabilities. The ordinance, as amended, was adopted at the December 6, 1982 Town Meeting:

The Board of Assessors, in accordance with this Ordinance, adopted under the authority of Section 12-81(c) of the Connecticut General Statutes, shall exempt from personal property taxation any ambulance-type motor vehicle which is used exclusively for the purpose of transporting any medically incapacitated individual, except any such vehicle used to transport any such individual for payment. Said exemption to be retroactive to the October 1982 Grand List.

The above ordinance became effective fifteen (15) days from date published in newspaper. ATTEST: Barbara B. Metsack, Town Clerk

The key eligibility criteria are:

- the vehicle must be registered with the CT Department of Motor Vehicles and must most frequently leave from and return to a property located in Ashford, CT;
- the vehicle cannot be used to transport any individual for payment;
- the vehicle must be inspected by the assessor before the exemption is granted. The assessor may inspect the vehicle at least once every Grand List year but is not required to; and,
- the modifications must have cost at least \$1,000.

Applications are available in the document holder on the wall outside of the Assessor's Office, and under Documents, Assessor on the town website. Questions? Call 860-487-4403 or email assessor@ashfordtownhall.org.

#### PA 490 Forest and Farm Use Classification - Reminders

Persons seeking to classify land under Farm, Forest or Open Space for the first time must file an application between September 1, 2022 and October 31, 2022 with the Assessor. Persons seeking to classify land as Forest must include a PA 490 certified forester's report dated on or before October 1, 2022.

New owners of formerly classified land must file a new application.

Changes to the original filing (e.g., ownership, use or acreage) must be reported annually.

#### **Exemption for Veterans and Active Duty with Prior Service Periods**

As a veteran or member of the armed services on active duty with prior service periods, you may be eligible for several exemption programs under the Connecticut General Statutes.

Filing Requirement: To be eligible for a basic veteran's exemption under CGS §12-81(19) and §12-81g, the first step is to file an original long-form DD214 in the Town Clerk's office showing an honorable discharge. If you do not have a copy, one can be requested at <a href="http://www.archives.gov/veterans/military-service-records/">http://www.archives.gov/veterans/military-service-records/</a>. The DD214 must be filed no later than 3 pm on Friday, September 30, 2022.

If you are unable to file the DD-214 prior to the 10/1/2022 assessment date due to active duty service, the serviceman can forward to the Town Clerk annually a written statement, signed by a commanding officer, or submit a notarized statement from a parent, guardian, spouse or legal representative of prior service. These documents must be received prior to 10/1. Contact the assessor for more information.

If you have an Other-than-Honorable discharge, you may still be eligible if you were discharged due to post traumatic stress disorder, a traumatic brain injury, or military sexual trauma. Contact the assessor for more information.

*Disabled Veterans:* If you have a disability rating from the VA of at least 10%, the exemption increases. To be eligible you will need a disability rating slip or letter from the US VA that specifies the percentage of disability. It is filed with the assessor once, unless the disability percentage changes.

Low Income Veterans: You may be eligible for a higher exemption if your 2021 calendar year household income was under \$38,100 if you are single and \$46,400 if you are married. If you are 100% VA-determined disabled, the income limits are \$18,000 for unmarried households or \$21,000 if married. Income for this program does not include VA disability benefits or economic stimulus payments.

Active Duty Members of the Armed Forces: You may be eligible for the exemption of one motor vehicle from taxation. The deadline to file an application for vehicles on the 2021 Grand List is December 31, 2023.

You will be contacted with the hearing date and time no later than Wednesday, March 1, 2023.

## The Importance of Indoor Ventilation Or Why is Thanksgiving Dinner an Airborne Toxic Event?

Ventilation is the process of bringing in new air to replace old, stagnant air. In humans it's called breathing. But houses need to breathe too in order to keep the air inside clean and healthy. New building standards ensure that we keep cold or hot air inside which increases the efficiency of heating and cooling and reduces the cost. That indoor air is most likely far more polluted that the air outside.

In America we spend 90% of our lives inside where we cook, breathe, bathe, clean up, and come and go. All of this "life activity" produces air pollution in many forms. Breathing, bathing, and cooking, for example, all result in moisture in the air which can cause mold and mildew. We use chemicals to clean our home, soaps, and detergents to clean ourselves and our belongings, cosmetic and deodorant products to keep us looking and smelling nice. Chemical components of these, as well as many other, daily use items become part of the air we breathe. Tobacco smoke and wood smoke are well known pollutants. Meal preparation and cooking can produce high levels of noxious gases and particulate matter. Scientists set up a test house where they constantly monitored air quality during daily life. Most notable was Thanksgiving dinner preparation day when CO2 reached 4,000 ppm, enough to decrease cognitive functioning (normal is ~1,000 ppm), and airborne particulates exceeded the monitor's measuring capability at over 100,000 ppcm3 (normal is ~2,000 ppcm3). In other words, if the test house was a city, it would have been labeled polluted and a public health alert triggered for "very unhealthy air".

Ventilation is one way to clear out and dilute accumulated pollutants. The easiest way to do this is to open windows or doors for at least 15 minutes daily, install and use an exhaust ventilation hood over the stove, and use an exhaust system in the bathroom. If possible, cook with electricity (stove, microwave, crock pot). If you have an HVAC system, check that the ducts are tightly sealed, and that the system produces 6 air exchanges per hour. We've learned through experience during the pandemic that we're safer outside than inside and that ventilation reduces the spread of airborne germs. We do know that outdoor air pollution is linked to heart disease, lung disease (including asthma and allergies), and cancer and there have been connections made to low birth weight, diabetes, and cognitive damage. Unfortunately, there have been almost no studies about the short- or long-term effects of indoor air pollution on health. We can't stop cooking, bathing, and cleaning, but at least we can open a window.

The Ashford School district announced today its policy for determining eligibility of children who may receive free or reduced-price meals served under the National School Lunch Program (NSLP) and School Breakfast Program (SBP), or free milk served under the Special Milk Program (SMP). The following income guidelines will be used in Connecticut from July 1, 2022, to June 30, 2023, for determining eligibility of participants for free and reduced-price meals and free milk in the Child Nutrition Programs.

Students residing in households with income at or below the levels shown in the chart above are eligible for free or reduced-price meals or free milk. Application forms have been sent to all homes with a letter to parents. To apply for free or reduced-price meals or free milk, households should fill out the application and return it to the school. The application is available to download on the Ashford School website, **school.ashfordct.org**, paper copies are available in the school office.

The information provided on the application is confidential and will be used only for the purposes of determining eligibility and for administration and enforcement of the lunch, breakfast, milk, and P-EBT programs. Additionally, all school-aged students in income-eligible households can receive school meal benefits regardless of a student's immigration status, and the district/school does not release information for immigration-related purposes in the usual course of operating the CNPs.

For up to 30 operating days into the new school year, a student's eligibility (free, reduced, or paid) as of June 2022 will be the eligibility that will be carried over for the first 30 operating days into SY 2022-23, starting with the first day of school. When the carry-over period ends, unless the household is notified that the students are directly certified or the household submits an application that is approved for free or reduced-price meals, the students must pay full price for SBP and NSLP school meals during SY 2022-23. Households will not be sent a reminder or a notice of expired eligibility in those districts participating in the National School Lunch or Breakfast Programs.

Special notice: During the transition back to normal school operations in school year 2022-23, the Ashford School district has opted in to the School Meals Assistance Revenue for Transition (SMART) funds providing meals (breakfast and lunch) at no cost for all students at the beginning of the school year. Please note that meals at no cost to all students are unlikely to last all year and are subject to the availability of district funds. Since the availability of meals at no cost will expire when all funds have been expended, it is critical that households submit a free and reduced-price meal application as soon as possible to determine a student's eligibility for this school year and avoid unpaid meal charges.

No application is required if the district directly certifies a student based on a household member receiving assistance from the Supplemental Nutrition Assistance Program (SNAP) or the Temporary Family Assistance (TFA) program, Medicaid (HUSKY A). Households receiving assistance under the SNAP/TFA or Medicaid programs will be notified of their eligibility in writing. Households receiving SNAP, TFA or Medicaid benefits for their children should only submit an application if they are **not** notified of their eligibility by **October 1, 2022**. If a student is not directly certified, the household should complete a free and reduced-price meal application form. The application for the SNAP or TFA households require the SNAP or TFA case number and the households may be asked to provide proof of the SNAP or TFA case number. The signature of an adult household member is also required.

When known to the district/school, households will be notified of any student's eligibility for free meals if the individual student is Other Source Categorically Eligible because the student is categorized as either: Homeless; runaway as defined by law and determined by the district or school's homeless liaison; or enrolled in an eligible Head Start or pre-kindergarten class as defined by law.

Households notified of their children's eligibility must contact the determining official or school if it chooses to decline the free meal benefits. If households/students are **not** notified by the district/school of their free meal benefits and they receive benefits under qualifying public assistance programs or under Other Source Categorically Eligible Programs, the parent/guardian should contact the determining official or their school.

If a household member becomes unemployed or if household size changes at any time, the household should contact the school to file a new application. Such changes may make the students of the household eligible for reduced-price meals, free meals, or free milk, if the household income falls at or below the levels shown in the Income Guidelines.







To promote and provide support to all businesses within the Towns of Ashford, Willington, and Eastford
To act as a collective resource of business information and education
To create awareness of Ashford, Willington, and Eastford business within the community
To address common business issues within Town governments
