NOTICE OF PUBLIC HEARING/SPECIAL TOWN MEETING SATURDAY, FEBRUARY 11, 2023, 10:00 A.M. ASHFORD SCHOOL CAFETERIA

The electors and citizens qualified to vote in the town meetings of the Town of Ashford, Connecticut, are hereby notified and warned that a Public Hearing/Special Town Meeting of said Town will be held at the Ashford School, 440 Westford Road in Ashford, Connecticut and remotely via ZOOM (see link below) on Saturday, February 11, 2023 at 10:00 a.m. for the purposes listed below. **Voting will be <u>in person</u> only.**

- 1. To conduct a Public Hearing on the proposed \$5,000,000 appropriation and borrowing authorization for the planning, design, and construction of a new roof at the Ashford School.
- 2. To elect a moderator for said Special Town Meeting;
- 3. To consider and act on the following resolution:
- (a) to appropriate the amount of \$5,000,000, and to authorize the issue bonds and notes of the Town in an amount not to exceed \$5,000,000 to finance the appropriation for the costs of the planning, design, and construction of a new roof at the Ashford School (the "Project"). The appropriation may be spent for design, construction, demolition and removal of materials, installation, permitting and environmental costs, equipment, materials, architectural, engineering and other consultant fees, legal fees, net interest on borrowings and other financing costs, and other expenses related to the Project and its financing, including the preparation of schematic drawings and outline specifications for the Project; to authorize the issue temporary notes of the Town in an amount not to exceed \$5,000,000 in anticipation of such bonds or notes and grants; and to authorize the First Selectman and the Treasurer of the Town to determine the amounts, dates, interest rates, maturities, redemption provisions, form and other details of the bonds or notes, and to perform all other acts which are necessary or appropriate to issue the bonds or notes. The Town anticipates applying for and receiving a grant from the State Department of Education to defray a portion of the eligible costs of the Project;
- (b) to take such action to allow temporary advances of available funds which the Town reasonably expects will be reimbursed from the proceeds of tax-exempt borrowings; and to authorize the First Selectman and the Treasurer to bind the Town pursuant to such representations and covenants as they deem necessary or advisable in order to maintain the continued exemption from federal income taxation of interest on the bonds, notes or temporary notes authorized by the resolution if issued on a tax-exempt basis, including covenants to pay rebates of investment earnings to the United States in future years, and to make representations and enter into written agreements for the benefit of holders of the bonds or notes to provide secondary market disclosure information, which agreements may include such terms as they deem advisable or appropriate in order to comply with applicable laws or rules pertaining to the sale or purchase of such bonds, notes or temporary notes;
- (c) to authorize the First Selectman, the Board of Education, and other proper officers and officials of the Town to apply for and accept federal and state grants to help finance the appropriation for the Project. Any grant proceeds may be used to pay project costs or principal and interest on bonds, notes or temporary notes; and
- (d) to authorize the Board of Selectmen, the Board of Education, the First Selectman, the Treasurer, and other proper officers and officials of the Town to take all other action which is necessary or desirable to construct and complete the Project, to issue bonds, notes or temporary notes and to obtain grants to finance the appropriation for the Project.

Assessment News

ELDERLY AND TOTALLY DISABLED TAX RELIEF PROGRAM - Connecticut law provides for tax relief for certain homeowners. Credits (reductions in taxes) are determined as a percentage of taxes and range from \$150 - \$1,250. To be eligible for the abatement on the 2022 Grand List:

- 1) You, or your spouse, must have been at least 65 years of age as of December 31, 2022; or you must be permanently and totally disabled (per Social Security or VA).
- 2) You must reside as the owner, or have life use, of the property as of October 1, 2022, and you must have lived in Connecticut for at least one year.
- 3) Your 2022 income cannot exceed \$49,100 if you are married or \$40,300 if you are unmarried. Qualifying income is defined as taxable income for IRS purposes AND non-taxable income, with limited exceptions.
- 4) You must provide the assessor with a copy of your SSA 1099 and your 2022 federal income tax return if you file one. If you do not file a tax return, proof of all 2022 income must be provided.

Applications are filed with the Assessor biennially from February 1st - May 15th. Persons already enrolled in the program were mailed an application at the end of January 2023. New applicants can download an application from the Assessor's page of the town's website at www.ashfordtownhall.org. You can also request an application package by emailing assessor@ashfordtownhall.org or calling 860-487-4403.

LEGAL NOTICE BOARD OF ASSESSMENT APPEALS TOWN OF ASHFORD

Property owners and lessees have the right under Connecticut General Statutes §12-111 and 12-504d to appeal the assessment of motor vehicles, personal property and real estate on the 2022 Grant List. CGS Section §12-117 requires written appeals to be received by the Board of Assessment Appeals no later than 3:00 p.m., Friday, February 17, 2023. Appellants will be notified of the date, time and place in early March 2023 when the BAA will hear their appeal. The appellant or its agent must appear personally for the BAA to hear their appeal.

The appeal form must contain all of the following information:

- 1. the property owner's name,
- 2. name and position of the signer,
- 3. description of the property which is the subject of the appeal,
- 4. name and mailing address of the party to be sent all correspondence by the BAA,
- 5. reason for the appeal,
- 6. appellant's estimate of value and
- 7. dated signature of the property owner or duly authorized agent of the property owner.

If any of these items are not provided, the Board can decide not to hear an appeal.

Greetings to the Ashford Community from Cynthia Ford, Superintendent



On December 15, 2022 it was a great honor to be appointed as Superintendent of Ashford Public School. I love this community and believe that this is a very special place. It is my hope to work together as a community to make necessary improvements while being fiscally responsible. A big part of that will be to continue open lines of communication.

What we spend on our students in this community is important and the community needs to be informed of those needs. It has been a busy couple of months! Students have come back from vacation ready to learn. We have started our second round of district assessments with iReady to see growth since the beginning of the year and to adjust teaching according to the scores. Students get very excited about their growth. Our new math program is continuing to be implemented with the guidance of a consultant to assist teachers along the way with questions as they come up throughout the year. After-school activities are in full swing. Some choices are: Math club, Winter Spirit, Strategy Games, Rubics Cube, Marifonnelly(Play group), SciFi Movies, Pokemon and Homework club. Basketball is also going strong, with the season moving right along. We have a Winter Recess coming in February 17th-22nd.

Building Update: We have had some bumps in the road this winter. Our generator broke down along with some issues with our boiler in December. We currently have a rental generator on site until we can get a quote and move to purchase a new one. The first step we have taken is to report this generator failure to our insurance since this happened during a power failure on December 23, 2022. The boiler has been repaired and has been working well.

Back in 2020 when our school was shut down due to COVID-19, along with many schools in the state, our water failed a lead test. We have been testing our water every month since and have passed the test each month. We had a deadline of January 17, 2023 to put in some proactive strategies to ensure our water is properly mixing. We have met that time line and will post the results of the next water test as soon as we have them. In collaboration with the Town of Ashford, we are working to purchase an underground storage tank for our heating oil to replace our aged-out tank. This will be installed this summer 2023. There will be no disruption to our students, as that is always our main goal as a community.

A Public Hearing/Special Town Meeting will be held on **Saturday February 11, 2023 at 10am in the school cafeteria** to talk about and take a vote on replacing the roof. There are important spaces, such as our school library, where the roof has zero insulation and when it rains it is difficult to focus due to the loud sound of rain hitting the roof. Replacing the roof will fix this issue; along with leaks that occur throughout the year, damaging equipment and space below, and reducing fossil fuel consumption. Replacing this roof will also allow the school to pursue solar panels to contribute to energy savings.

Budget: The Board of Education in collaboration with the school administration has been systematically going through our budget for the upcoming school year. We were asked to have a preliminary estimate to the towns Board of Finance by January 13, 2023. This will give the BOF time to see what the tax implications are for the town residents and to problem solve and work collaboratively with the departments to put the best budget forward for our town as a whole. Our preliminary numbers are an increase of 4.44%. A presentation to the Board of Education will take place on February 2, 2023 of exactly what is planned and needed to continue improving our educational process through our state test scores, and to create an environment where children love to learn and have controlled choices around their education. Now is the time to tune in to your Board of Education meetings and Board of Finance meetings to see the amount of work that happens prior to the budget going to the town referendum. Your voices are heard and are encouraged.



Notice is given to Ashford taxpayers that the second installment of Real Estate & Personal Property taxes, and the Motor Vehicle Supplemental taxes on the Grand List of Oct. 1, 2021 becomes due and payable on January 1, 2023 and is payable without interest penalty through February 1, 2023. After Feb.1, 2023, interest will accrue at 1 ½% per month from the due date of Jan. 1, or a minimum interest charge of \$2.00.

Hence, during Feb., the interest is calculated at 3%, or the minimum of \$2.00, whichever is greater.

Failure to receive a tax bill does not invalidate the tax or interest penalty (CGS 12-130).

Fire Extinguisher Safety


Putting out a fire quickly before it escalates is important both for personal safety and preventing property damage. The best way to respond quickly and control fires is to have a fire extinguisher within reach of the source. Time is of the essence in a fire emergency, and you don't want to be running around the house in a panic looking for a fire extinguisher. With proper fire extinguisher placement, you will be prepared to act quickly in the case of a fire in your

<u>The Kitchen:</u> 65% of all fires start in the kitchen, which makes this the most important room to have a fire extinguisher in your home. A Class K extinguisher is necessary in your kitchen because it's designed to specifically put out fire fueled by vegetable and animal oils and fats.

The Garage / Utility Room / Workshop: If you have a garage or a workshop, then you probably use these spaces to store some flammable materials. Paints, oil, gasoline, solvents, and other chemicals are all extremely combustible. When working with tools in a workshop, you might generate sparks that could lead to a serious fire. Keeping a fire extinguisher in this area is a must.

The Laundry Room: Your dryer is another likely place for a fire to start. The lint that collects in your dryer is highly flammable and might catch fire when the dryer is in operation due to high temperatures. Clean the lint trap after every load to reduce this possibility. The dryer exhaust tube may also fill with lint, be sure to clean this out every six months. These practices will help prevent fires, but just in case, you will want a fire extinguisher in or near your laundry room.

The Patio and Grill: Patios are ideal for enjoying the great outdoors. If you have a grill or a fire pit, then you will want to place a fire extinguisher nearby. Gas grills can be especially dangerous because the propane fuel is explosive. If you grill over charcoal, the grease from cooking and the hot coals may cause a serious fire. Decks and patios are great spots for a fun gathering, but you need to keep safety in mind as well.



Each Floor of your Home: Every floor of your home needs at least one fire extinguisher. Mount it on the wall in a central location about 4 to 5 feet above the ground. Don't hide the fire extinguisher behind drapes or curtains and don't store fire extinguishers in closets. They need to be in plain view, or you will not be able to find them when you need them.

A standard Class A-B-C extinguisher is suitable for most every home, along with a Class K for your kitchen. Use your extinguisher only to keep a small self-contained fire from growing, only when the room is not filled with smoke, or to create a safe pathway out of the home. Be sure to read the instructions and become familiar with your fire extinguisher's parts and operation before a fire breaks out.



Leadership Meeting Moves Ashford Forward

A town wide Leadership Meeting was held on November 16. Our First Selectman William Falletti welcomed the over 25 participants. He expressed appreciation for all the residents volunteering in any capacity on a board, commission, civic organization or other group in town, as well as town staff, who are all dedicated to continuing to make Ashford a great place to live, work and enjoy.

The objectives of the meeting were to:

- 1. Follow-up to the November 2019 Leadership Meeting,
- 2. Highlight Accomplishments of the 2015 Plan of Conservation of Development (POCD)
- 3. Begin to seek input from citizens on the mandated 2025 update to the POCD, and
- 4. Identify and create future goals and objectives

Jeff Silver-Smith, Chairman of Planning and Zoning served as the main moderator for the meeting, with the members of Our Town Our Future (OTOF) Committee providing meeting coordination support.

Jeff Silver-Smith gave a brief overview of the purpose of the meeting and highlighted some of the accomplishments of the 2015 POCD since the last Leadership meeting in November of 2019.

Participants introduced themselves and were asked to share their thoughts on what is most critical for Ashford, as a community, to focus on going forward. The following items represent the most common responses:

- 1. How to increase the tax base and find other sources of revenue to reduce or mitigate the tax burden on residents,
- 2. Developing a Strategic Plan-to help determine the future of the town,
- 3. Addressing the need for additional Senior, as well as, Affordable Housing in Ashford,
- 4. Protecting the Town's environment, its history, and our rural character, and
- 5. How to best recognize younger residents and promote their engagement in the functions of our community.

Using the above as discussion points, the attendees were asked to breakout into five groups to discuss how each subject might be developed further. This resulted in some excellent ideas, all of which have been documented and can be found on the Town's website under the Our Town Our Future Committee tab under Agendas and Minutes (https://ashfordtownhall.org/agendas-and-minutes/our-town-our-future-committee/)



Reservations for summer camp at JN Webster have been confirmed and will be week 4 in July.


Our next fund raiser will be the annual Mother's Day Flower Sale in May.
