- No Declaration is filed (Conn. Gen Stat. §12-41(e), §12-42).

The penalty CANNOT be removed by the Board of Assessment Appeals (Conn Gen Stat. §12-114, §12-119a).

Filing Extension Request – A request for a filing extension for good cause (§12-42) is possible if it is received on or before 11/1/2023 at 3:00 pm. The request must be in writing or by email to assessor@ashfordtownhall.org
