- 3. Hear from the public: no members of the public wishing to be heard at this time
- 4. First Selectman's Briefing
  - Falletti reported that Bridge No. 003002 over Bigelow Brook collapsed last Friday evening creating a dangerous condition on Barlow Mill Road. The road has been closed to thru traffic while remediation options are being assessed.
  - Installation of split units at Knowlton Hall has been completed. Nutmeg Mechanical will run a training session for Library and TOB staff.
  - Senior Housing reports five new COVID cases
  - Complaints regarding dirt bike and quad usage on private property and town roads continue to be reported. State police have been contacted for advice on how to handle.

  - A. Correction to minutes of 8/15/2022: The following motion was inadvertently omitted from the minutes of 8/15/2022: Agenda Item 7.D. After school childcare program: Silver-Smith moved that the BOS support continuation of the Parks & Recreation Department research, with the board of Education and the Social Services Department, into the concept and workings of the proposed after school childcare program. Phillips seconded the motion which passed unanimously.
